a. Compulsory Regulation Items (Rec to Year 6):

- i. Regulation unisex black winter coat (with school badge)
- ii. Regulation cherry red blazer with grey piping
- iii. Regulation cherry red V-necked sweater with stripe or sleeveless pullover with stripe
- iv. Regulation red/grey striped school tie. (Clip-on tie in two sizes for infant and junior boys)
- v. Regulation navy / red PE / games shorts (with school badge)
- vi. Regulation navy / red PE / games shirt (with school badge)
- vii. Regulation white / red PE / polo shirt (with school badge)
- viii. Regulation navy (with red stripe) knee length socks for games
- ix. Regulation white (with red stripe) socks for PE
- x. Regulation navy/ red tracksuit
- *xi.* Regulation black rucksack (with school badge)
- *xii.* Regulation navy sun hat

b. Compulsory Regulation items (Rec - Year 2 only)

- i. Regulation cherry red School cap
- ii. Regulation black draw-string bag (with school badge) for PE kit
- iii. Regulation black book bag (with school badge)

c. Compulsory Regulation items (Year 3 to Year 6 only)

i. Regulation black bag for sports / PE kit (with school badge)

d. Compulsory Regulation items (Year 1 to Year 6 only)

- i. Regulation navy swimming trunks (a choice from two styles)
- ii. Regulation black draw-string bag (with school badge) for swimming kit)
- iii. Silver Highclare swimming hat

e. Optional Regulation items (i.e. No other item is acceptable)

- i. Regulation School scarf
- ii. Regulation grey beanie hat to wear in playground or severe weather
- iii. Regulation navy hooded top for trips and activities

2. Non- Regulation Items – available from High Street stores

a. Compulsory Non-Regulation items

- i. White shirt, long or short sleeved
- ii. Black ankle socks
- iii. Plain black shoes. These should not be black trainers nor trainers sold on the high street as shoes.
- iv. Football boots (must be moulded or screw in studs, NO BLADES of any description)
- v. Art overall (or old shirt)
- vi. Two pairs of plain black or white trainers for outdoor PE and indoor PE
- vii. Shin pads

b. Optional Non-Regulation items

- i. Gloves (plain grey or black)
- ii. Navy base layers for PE / Games (Year 3 6 only)

3. Appearance - High standards of appearance and conduct are required at all times.

- a. Watches If watches are worn, please make them suitable for school use in muted colours.
- Jewellery no jewellery, apart from one small pair of plain gold/silver ear studs, are allowed which must be covered by swimming hats for swimming or taped over with micropore tape for PE
- c. Hair Hair must be clean, tidy, short and a natural colour. Hair should be arranged tidily in a conventional style. Shaven heads or hair cut so that the head or parts of it appear to be shaven are not allowed. (e.g: no tramlines and Mohican styles). No gel or other hair styling products are permitted.
