1. Regulation items – only available from Clive Mark Schoolwear.
2. Non- Regulation Items – available from any good retailer / high street stores.
3. Appearance - High standards of appearance and conduct are required at all times.

1. Regulation items – only available from Clive Mark Schoolwear:

a. Compulsory Regulation Items (U3 to U5):

- i. Regulation grey wool blazer with red piping
- ii. Regulation charcoal grey trousers (*no other colour allowed*)
- iii. Regulation black V-necked sweater or sleeveless pullover with red stripes on neckline (and embroidered in house colour)
- iv. Regulation white shirt (long or short sleeved)
- v. Regulation cherry school tie
- vi. Regulation black school bag

b. Compulsory Regulation PE kit (U3 to U5)

- i. Regulation PE bag for sports equipment (with school badge)
- ii. Regulation white/red polo shirt (with school badge)
- iii. Regulation navy/red games shorts (with school badge)
- iv. Regulation navy/red PE/games shirt (with school badge)
- v. Regulation navy/red tracksuit
- vi. Regulation navy/red games socks
- vii. Regulation white (with red stripe) PE socks

c. Optional Regulation items (i.e. No other item is acceptable)

- i. Regulation School scarf
- ii. Regulation grey beanie hat to wear in playground or severe weather
- iii. Regulation (navy) cap for summer sport (with school badge)

2. Non- Regulation Items – available from any good retailer:

a. Compulsory Non-Regulation items (all)

- i. Plain black coat (no logos, fur trim, extreme styles etc)
- ii. Black ankle socks
- iii. Plain black shoes. These should not be black trainers nor trainers sold on the high street as shoes.
- iv. Art overall (or old shirt)
- v. Scientific Calculator (equivalent of Casio FX 991)
- vi. Football boots (moulded or studs)
- vii. Trainers (sold for sport, not fashion ware)
- viii. Shin pads

b. Compulsory Non-Regulation items (U3 to U4 only)

- i. White cookery apron for food and nutrition
- ii. Cookery bag (available from School) or cookery basket
- iii. Swimming trunks or shorts designed for swimming in a plain colour and style (U3 and L4 only)

c. Optional Non-Regulation items (all)

- i. Gloves (plain grey or black)
- ii. Navy base layers for PE / Games
- iii. Any religious head coverings should be in muted / plain colours

3. Appearance - High standards of appearance and conduct are required at all times.

- i. Make up - No make- up, fake tan, nail polish or nail extensions are allowed
- ii. Jewellery – no jewellery, apart from one small pair of plain ear studs, are allowed.
- iii. Hair – Hair must be clean, tidy and a natural colour (we will NOT accept unnatural, excessive or extreme changes in colour). Hair should be arranged tidily in a conventional style. For safety and practicality, long hair should be tied back and hair ties / hair bands should be small and plain in grey, black, maroon or muted colours. No fancy hair slides or decorations. Beaded braided hair is only allowed for a maximum of two weeks, following a holiday. Shaven heads, or hair cut so that the head, or part(s) of it appear to have been shaven are not allowed (eg: no tramlines and Mohican styles).
